I have sufficient knowledge about the arrangements made by the Applicant Organisation in relation to the proposed exit poll. I am also responsible for the supervision, on behalf of the Applicant Organisation, of the conduct of the exit poll, including the conduct of those persons who will be assigned with any duty in the exit poll and those who will be assigned to conduct the exit poll as listed in Attachment I.

- I am not contesting in any Legislative Council geographical constituencies / functional constituencies covered by the exit poll. * The bodies to which I belong / The Applicant Organisation have / has no member contesting in any Legislative Council geographical constituencies / functional constituencies, of which any polling stations are covered by the exit poll. I, * the bodies to which I belong / the Applicant Organisation and members thereof have not publicly expressed support for any candidates / lists of candidates contesting in any Legislative Council geographical constituencies / functional constituencies, of which any polling stations are covered by the exit poll.

- * I / The Applicant Organisation and I will not assign (1) member(s) of any organisation which has members contesting in any Legislative Council geographical constituencies / functional constituencies, of which any polling stations are covered by the exit poll; (2) member(s) of any organisation which has publicly expressed support for candidates / lists of candidates contesting in any Legislative Council geographical constituencies / functional constituencies, of which any polling stations are covered by the exit poll; or (3) any person who has publicly expressed support for candidates / lists of candidates contesting in any Legislative Council geographical constituencies / functional constituencies, of which any polling stations are covered by the exit poll to assume any duty in the exit poll or to conduct the exit poll on the polling day. If there is a change of circumstances after submission of the Application Form such that any person listed in Attachment I falls into one of the categories mentioned above, * I / The Applicant Organisation and I will amend the list under Attachment I to ensure that no person belonging to the three categories above is assigned to conduct the exit poll, and will submit the updated list to the Registration and Electoral Office (“REO”) as soon as possible before the polling day.

9. * 本人／本人及申請機構不會在投票結束前，直接或間接向任何在票站調查涵蓋的立法會地方選區／功能界別參選的候選人、任何已公開表明支持在票站調查涵蓋的立法會地方選區／功能界別參選的任何候選人／候選人名單的人士或機構、或任何已有成員在票站調查涵蓋的立法會地方選區／功能界別參選的機構，發放票站調查的結果或就任何候選人／候選人名單的表現發表具體評論或預測。
- * I / The Applicant Organisation and I will not release, directly or indirectly, the results of the exit poll or make specific remarks or predictions on the performance in relation to any candidate / list of candidates to any candidate contesting in the Legislative Council geographical constituencies / functional constituencies covered by the exit poll, any person who or organisation which has publicly expressed support for any candidate / list of candidates contesting in the Legislative Council geographical constituencies / functional constituencies covered by the exit poll, or any organisation with member(s) contesting in the Legislative Council geographical constituencies / functional constituencies covered by the exit poll, before the close of poll.

 - 不得在指定為禁止逗留區的範圍內逗留或遊蕩或趨前與選民交談；
 - 在票站外進行調查期間，不可與候選人或其代理人談話或通信息；及
 - 不得在禁止拉票區範圍內向選民拉票或作出任何會令人懷疑是向選民拉票的行為（請參閱《指引》第 14 章）。

* I / The Applicant Organisation and I will conduct the exit poll only for the purpose as stated in Part III of the Application Form, and in full compliance with the rules governing the conduct of exit poll in the Guidelines on Election-related Activities in respect of the Legislative Council Election (“the Guidelines”) and the relevant supplementary information (if any) issued by the EAC, especially Chapter 15, including but not limited to the following requirements to be observed by those persons listed in Attachment I -

- display prominently the identification device issued by the REO when conducting the exit poll;
- respect the electors’ right and wish not to be disturbed;
- prior to conduct of exit poll, use the standard script provided by the REO to inform the electors being interviewed that their participation in the exit poll is purely voluntary;
- make known to the electors the name of the person or organisation conducting exit poll at the start of the interview and that the exit poll is not commissioned by the Government;
- not to collect or retain any personal data (such as name and Hong Kong Identity Card number) relating to the identity of the electors;
- not to stay or loiter or accost electors in the areas designated as the No Staying Zone;
- not to speak to or communicate with candidates or their agents when conducting the poll outside polling stations; and
- not to canvass electors in the No Canvassing Zone or carry out any activities that will give rise to suspicion that they are canvassing electors inside the No Canvassing Zone (please refer to Chapter 14 of the Guidelines).

11. 本人明白，所有被委派在是次票站調查中擔任任何職務的人士，以及附件一列明的人士，亦須遵守《指引》內關於進行票站調查的規定以及本部分第 4 至 10 及 13 段所述事項。因此，* 本人／本人及申請機構會確保所有上述人士均接受一切必需的訓練及督導，以使他們知悉和嚴格遵守上述規定和事項。

I understand that all persons assigned to assume any duty in the exit poll and all persons listed in Attachment I shall also observe the rules in the Guidelines governing the conduct of exit poll and the matters stated in paragraphs 4 to 10 and 13 of this Part. Therefore, * I / The Applicant Organisation and I will ensure that all persons mentioned above are given all necessary training and supervision, so that they know and strictly comply with the above rules and matters.

I understand that, if * I or any person conducting the exit poll / I, the Applicant Organisation or any person conducting the exit poll fail(s) to comply with the rules in the Guidelines governing the conduct of exit poll or the matters stated in paragraphs 4 to 10 of this Part, the EAC may revoke the approval to

conduct exit poll on the polling day or during the polling hours forthwith without prior warning. The EAC may also make a reprimand or censure in a public statement which will include the name of the person or organisation who / which fails to comply with this declaration or the Guidelines and may take legal action against such person or organisation.

1. 在填寫此申請表前，請細心閱讀《立法會選舉活動指引》及相關補充資料頁（如有的話）。
Please read the Guidelines on Election-related Activities in respect of the Legislative Council Election and the relevant supplementary information (if any) carefully before completing this Application Form.
2. 請用中文或英文填寫此申請表。
Please complete this Application Form either in Chinese or in English.
3. 有意申請進行票站調查的機構，在決定由誰人作出法定聲明時，應考慮該人是否符合申請表第一部分第1段所述的要求。
Any **organisation** which intends to apply to conduct exit poll, when deciding who is to make the statutory declaration, should consider whether such person satisfies the requirements stated in paragraph 1 of Part I of the Application Form.

The **original** of the completed Application Form must be submitted in person or by post to the Registration and Electoral Office (“REO”), (Address: Room 1377, 13th Floor, Kowloonbay International Trade & Exhibition Centre, 1 Trademart Drive, Kowloon Bay, Kowloon (Attention: Special Support Team of Elections Division)), not later than 10 days before the polling day (i.e. on or before 6:00 p.m. on 25 August 2016). If applicants do not provide accurate data as requested in this Application Form 10 days before the polling day, their application to conduct exit poll may not be processed.

If applicants do not receive any reply from the REO 7 days after submission of their application, please call the Enquiry Hotline at 2891 1001 to check the progress of their application.
6. 請保留一份申請表的副本作參考之用。
Please keep a copy of the Application Form for future reference.
7. 根據《立法會條例》（第542章）第3條，“身分證明文件”指 –
 - (a) 根據《人事登記條例》（第177章）向某人發出的身分證；或
 - (b) 在根據該條例訂立並正有效的規例下向某人發出，並證明該人獲豁免而無須根據該條例登記的文件；或

The personal data and other information supplied in connection with this Application Form will be used by the REO for election-related purposes. A list of organisations or persons allowed to conduct exit poll together with their contact telephone numbers will be released to the public prior to the polling day for reference by the public and candidates. Such a list will also be displayed at the respective polling stations. All the identity document number(s) and the declarant's address will be covered before display.

(b) Transfer of Information

The personal data and other related information supplied in connection with this Application Form may be provided to other authorised departments or persons including but not limited to the law courts for election-related purposes.

(c) Access to Personal Data

A person has the right to request access to and correction of the personal data he/she supplied in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

(d) Personal Data Protection Principles

Applicants are reminded to observe the Data Protection Principles in Schedule 1 to the Personal Data (Privacy) Ordinance (Cap.486) in collecting personal data of a third person in

completing this Application Form, in particular Principle 4 concerning the requirement to take all practicable steps to ensure that the personal data are protected against unauthorised or accidental access and processing.

(e) Enquiry

Enquiries concerning the personal data collected by means of this Application Form, including requests for access to and corrections of personal data, should be addressed to the Chief Electoral Officer at 10th Floor, Harbour Centre, 25 Harbour Road, Wanchai, Hong Kong.
