## 2022 Chief Executive Election Admission Arrangement for the Central Counting Station cum Media Centre

The Central Counting Station cum Media Centre ("CCS-cum-MC") of the 2022 Chief Executive Election will be set up at Hall 3 of the Hong Kong Convention and Exhibition Centre ("HKCEC"), Wan Chai. Members of the public can enter the public area in the CCS-cum-MC to observe the counting of votes and the announcement of election result.

## Members of the Public

Owing to the limited space and the implementation of social distancing measures in the CCS-cum-MC, the seating capacity of the public area is limited to 400. Starting from 10:30 a.m. on 8 May 2022, members of the public will be admitted to the CCS-cum-MC on a "first-come, first-served" basis via the Harbour Road Entrance. They are required to go through the security check before entering or re-entering the CCS-cum-MC and to wear a wristband provided by the Registration and Electoral Office ("REO") for identification purpose at the point of admission at the Convention Hall on 1/F of the HKCEC. A total of 400 wristbands will be distributed, while stocks last.

Before entering the CCS-cum-MC, all persons are required to follow the following admission arrangements -

- 1. Upon the implementation of the "vaccine pass" arrangements, to have received at least 2 doses of vaccine, save for those who hold specified medical exemption certificates or other exempted persons.
- 2. To wear masks properly and be subject to body temperature screening. use the "LeaveHomeSafe" mobile application to scan the CCS-cum-MC QR code. Persons who are aged below 12 or aged 65 or above, and those with disabilities that render use of the app difficult, will be exempted from the requirement of using the app when they enter the CCS-cum-MC. However, they are required to complete a record form to register their names, the first four digits or letters of their identification documents, their contact numbers and the date and time of their visits. They are also required to present relevant identification documents for verification at the request of the staff of the REO or the HKCEC on site during registration. The staff of the REO or the HKCEC will also verify the contact numbers provided by the aforesaid persons by making phone calls. The REO may deny entry to the CCS-cum-MC of any persons who refuse to comply with the above preventive measures or persons with signs of fever, or persons with respiratory symptoms or sudden loss of taste or smell.
- 3. To observe the House Rules and go through the metal detector and bag search process before entering the CCS-cum-MC.
- 4. To put on the wristbands within the CCS-cum-MC for identification and re-entry purpose.
- 5. To go through the metal detector and bag search process again upon reentering the CCS-cum-MC.
- 6. When leaving the CCS-cum-MC with **NO** intention of re-entry, please inform the security guards at the exit of the CCS-cum-MC who will assist you to remove the wristbands.
- 7. No replacement for any lost or damaged wristbands will be arranged.
