Consents have been given by the prescribed bodies and persons concerned for printing the above registered names and emblems on the ballot papers.
- (2) All the above registration of the names and emblems of prescribed bodies and persons have been approved by the Electoral Affairs Commission.
- (3) Please also refer to the Register maintained under section 20 of the Particulars Relating to Candidates on Ballot Papers (Legislative Council and District Councils) Regulation (Cap. 541M) (https://www.eac.hk/pdf/legco/2019/Emblem_Contents_2019.pdf), which may contains additional information (e.g. name of the body, abbreviation of the name of the body) provided by some prescribed bodies in Chinese only.
