On receiving each election donation, whether by way of money, goods or service, of more than \$1,000 in value, a candidate must issue to the donor a receipt which specifies the name and address of the donor (as supplied by the donor) and the particulars of the election donation.
- 選舉捐贈收據的正本應交予捐贈者，副本由候選人保存作記錄。
The original of the receipt for election donations should be given to the donor, and a copy should be kept by the candidate for record.
- 候選人應另製備選舉捐贈收據的副本，以便連同「接受選舉捐贈預先申報書及聲明書」（表格編號：REO/C/16/2016ECSSE(SDF)）（如適用）及「選舉開支及接受選舉捐贈之申報書及聲明書」（表格編號：REO/C/1/2016ECSSE(SF)）一併向總選舉事務主任提交。
