 - display prominently the identification device issued by the REO when conducting the exit poll;
 - respect the electors' right and wish not to be disturbed;

- prior to conduct of exit poll, use the standard script provided by the REO to inform the electors being interviewed that their participation in the exit poll is purely voluntary;
- make known to the electors the name of the person or organisation conducting exit poll at the start of the interview and that the exit poll is not commissioned by the Government;
- > not to collect or retain any personal data (such as name and Hong Kong Identity Card number) relating to the identity of the electors;
- > not to stay or loiter or accost electors in the areas designated as the No Staying Zone;
- not to speak to or communicate with candidates or their agents when conducting the poll outside polling stations; and
- ➤ not to canvass electors in the No Canvassing Zone or carry out any activities that will give rise to suspicion that they are canvassing electors inside the No Canvassing Zone (please refer to Chapter 14 of the Guidelines).

If applicants fail to provide accurate data as requested in this Application Form 10 days before the polling day, their application to conduct exit poll may not be processed.

Such a list will also be displayed at the respective polling stations. All the identity document number(s) and the declarant's address will be covered before display.

(b) Transfer of Information

The personal data and other related information supplied in connection with this Application Form may be provided to other authorised departments or persons including but not limited to the law courts for election-related purposes.

(c) Access to Personal Data

A person has the right to request access to and correction of the personal data he/she supplied

in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

(d) Personal Data Protection Principles

Please note that applicants must observe the Data Protection Principles in Schedule 1 to the Personal Data (Privacy) Ordinance (Cap. 486) in collecting personal data of a third person in completing this Application Form, in particular Principle 4 concerning the requirement to take all practicable steps to ensure that the personal data are protected against unauthorised or accidental access and processing.

(e) Enquiry

Enquiries concerning the personal data collected by means of this Application Form, including requests for access to and corrections of personal data, should be addressed to the Chief Electoral Officer at 10th Floor, Harbour Centre, 25 Harbour Road, Wanchai, Hong Kong.
