- by display prominently the identification device issued by the REO when conducting the exit poll;
- respect the electors' right and wish not to be disturbed;
- prior to conduct of exit poll, use the standard script provided by the REO to inform the electors being interviewed that their participation in the exit poll is purely voluntary;
- make known to the electors the name of the person or organisation conducting exit poll at the start of the interview and that the exit poll is not commissioned by the Government;
- > not to collect or retain any personal data (such as name and Hong Kong Identity Card number) relating to the identity of the electors;
- > not to stay or loiter or accost electors in the areas designated as the No Staying Zone;
- > not to speak to or communicate with candidates or their agents when conducting the poll outside polling stations; and
- > not to canvass electors in the No Canvassing Zone or carry out any activities that will give rise to suspicion that they are canvassing electors inside the No Canvassing Zone (please refer to Chapter 14 of the Guidelines).

Therefore, \* I / The Applicant Organisation and I will ensure that all persons mentioned above are given all necessary training and supervision, so that they know and strictly comply with the above rules and matters.

The EAC may also make a reprimand or censure in a public statement which will include the name of the person or organisation who / which fails to comply with this declaration or the Guidelines and may take legal action against such person or organisation.

- 1. 在填寫此申請表前,請細心閱讀《立法會選舉活動指引》及相關補充資料頁(如有的話)。 Please read the Guidelines on Election-related Activities in respect of the Legislative Council Election and the relevant supplementary information (if any) carefully before completing this Application Form.
- 2. 請用中文或英文填寫此申請表。
  Please complete this Application Form either in Chinese or in English.
- 3. 有意申請進行票站調查的**機構**,在決定由誰人作出法定聲明時,應考慮該人是否符合申請表 第一部分第1段所述的要求。

Any <u>organisation</u> which intends to apply to conduct exit poll, when deciding who is to make the statutory declaration, should consider whether such person satisfies the requirements stated in paragraph 1 of Part I of the Application Form.

The <u>original</u> of the completed Application Form must be submitted in person or by post to the Registration and Electoral Office ("REO"),(Address: Room 1377, 13<sup>th</sup> Floor, Kowloonbay International Trade & Exhibition Centre, 1 Trademart Drive, Kowloon Bay, Kowloon (Attention: Special Support Team of Elections Division)), not later than 10 days before the polling day (i.e. on or before 6:00 p.m. on 25 August 2016). If applicants do not provide accurate data as requested in this Application Form 10 days before the polling day, their application to conduct exit poll may not be processed.

If applicants do not receive any reply from the REO 7 days after submission of their application, please call the Enquiry Hotline at 2891 1001 to check the progress of their application.

- 7. 根據《立法會條例》(第542章)第3條,"身分證明文件"指 -
  - (a) 根據《人事登記條例》(第177章)向某人發出的身分證;或
  - (b) 在根據該條例訂立並正有效的規例下向某人發出,並證明該人獲豁免而無須根據該條例 登記的文件;或
  - (c) 向某人發出的獲選舉登記主任接受為該人的身分證明的任何其他文件。

According to section 3 of the Legislative Council Ordinance (Cap. 542), "identity document" means -

- (a) an identity card issued to a person under the Registration of Persons Ordinance (Cap. 177); or
- (b) a document issued to a person under regulations in force under that Ordinance certifying that the person is exempt from being required to register under that Ordinance; or

(c) any other document issued to a person that is acceptable to the Electoral Registration Officer as proof of the person's identity.

#### (e) 查詢

#### (a) <u>Purpose of Collection</u>

The personal data and other information supplied in connection with this Application Form will be used by the REO for election-related purposes. A list of organisations or persons allowed to conduct exit poll together with their contact telephone numbers will be released to the public prior to the polling day for reference by the public and candidates. Such a list will also be displayed at the respective polling stations. All the identity document number(s) and the declarant's address will be covered before display.

#### (b) Transfer of Information

The personal data and other related information supplied in connection with this Application Form may be provided to other authorised departments or persons including but not limited to the law courts for election-related purposes.

#### (c) Access to Personal Data

A person has the right to request access to and correction of the personal data he/she supplied in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

## (d) Personal Data Protection Principles

Applicants are reminded to observe the Data Protection Principles in Schedule 1 to the Personal Data (Privacy) Ordinance (Cap.486) in collecting personal data of a third person in

completing this Application Form, in particular Principle 4 concerning the requirement to take all practicable steps to ensure that the personal data are protected against unauthorised or accidental access and processing.

## (e) Enquiry

Enquiries concerning the personal data collected by means of this Application Form, including requests for access to and corrections of personal data, should be addressed to the Chief Electoral Officer at 10<sup>th</sup> Floor, Harbour Centre, 25 Harbour Road, Wanchai, Hong Kong.
