




Invalid – An elector expressed to the Presiding Officer that he/she has made an error in marking the ballot paper and applied for another ballot paper. The Presiding Officer accepted his/her explanation and issued a new ballot paper. In accordance with section 62(3) of the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation ("the Regulation"), the ballot paper given back to that Officer must be cancelled by endorsing on the front of it with the words "損壞" and "SPOILT". In accordance with section 80(1)(c) of the Regulation, a ballot paper endorsed with the words "損壞" and "SPOILT" on the front of it is not to be regarded as valid.


